The Board of Trustees recently approved an increase to the water and sewer taps for new construction. The new rates are:

WATER	<u>SEWER</u>
5/8" - \$20,000	5/8" - \$8,000
3/4" - \$23,000	3/4" - \$10.00

Additional rates may be see on the Town's fee schedule.












- 1. Call 811 or go to your state 811 center's website a few days before digging to request that buried utilities in your yard be marked.
- 2. Wait a few days for all utilities to respond to your request.
- 3. Confirm that all utilities have responded.
- 4. Respect the utility marks or flags.
- 5. Dig carefully around buried utilities.





TOWN OF WIGGINS COMPREHENSIVE PLAN GRANT

The Town of Wiggins recently received a grant from DOLA to update the Town's Comprehensive Plan. The plan was last updated in 1991. Staff will be working to select a consultant to assist in this effort during the 1st Quarter of 2022. The Town will be looking for citizen involvement as it updates the Town's Comprehensive Plan. Contractor Reminder to Renew

ALL Contractor's Licenses must be renewed PRIOR to continued work in Wiggins. This license renewal is required by ordinance each calendar year. Applications may be found on the Town's website: townofwiggins.colorado.gov/departments/townclerk. The application, Certificate of Insurance, driver's license, and master trade licenses (if applicable) must be returned via:

DOGS AT LARGE

The Town of Wiggins has recently experienced a large number of dogs at large. It is the dog owners responsibility to ensure that property

fences are maintained and gates are secure to prevent gates from blowing open during wind events. Dogs running at large may be picked up and taken to the shelter in Brush. Retrieval of the dog requires payment of a shelter fee. Dog owners may also be given a \$140 summons to the Wiggins Municipal Court. All dogs are required to be vaccinated and registered with the Town of Wiggins. Additional fines may be added to the summons if homeowners can not show proof of current rabies vaccination and registration. Dog License registration may be completed at the Town Hall for \$5 per dog. Proof of current rabies vaccination is required at time of registration. Registration will assist the department in returning dogs to owners without taking them to the Brush shelter.

The Town does not have facilities to keep dogs. If you restrain a dog that comes on to your property, you may be asked to temporarily keep the dog (up to 24 hours) until the owner can be found. Feel free to utilize the Town or Police Department Facebook pages to locate the owners. It is often best to allow the dog to find its way back home or call the non-emergency dispatch line at 970-483-7747.

Dogs are required to be leashed when being walked around town to prevent unexpected, dog encounters and potential violent interactions with other dogs or people.

ATV Tag Renewal Reminder—2022

Residents are reminded to renew all ATV tags for the 2022 year. All ATV's and golf carts must be registered with the Wiggins Police Department before being driven on streets within the Town of Wiggins. Proof of insurance and payment may be brought in to the Town Hall to obtain a tag.

Tags are \$20.

Ask Staff Code Enforcement

This is a section where staff answer some of the questions most often asked by residents and business owners. The Wiggins Police Department & the Planning & Zoning Department collaborate together to investigate possible violations of the Town's code.

Q: What are the most common code violations?

- A: The most common violations include piles of trash, junk, debris, and weeds along properties in alley ways and in yards. Since these violations directly impact the quality of life in your neighborhood, these properties receive Courtesy Notices. A clean and neat street with no piles of trash and weeds in sight makes a big difference!
- Q: What are some things people may not know about the Town Code?
- A: People are usually most surprised to learn that "there's a permit required for that work?". Often, even minor improvements or changes to your home or business require filing for a building permit with the Town. Town Staff recommends you inquire with the Planning & Zoning Department to ask whether you will need a permit before beginning a home improvement project. In addition, residents within Homeowner's Associations must also inquire with their HOA.

Q: How do I report a code violation?

- A: Drop by the Town Hall at 304 E Central Avenue or fill out the electronic complaint form on the Town's website. Please be ready to provide your name and address.
- Q: What if I get a letter from the Town regarding a Code Compliance?
- A: If you need any clarification on what was sent to you, contact the staff member at the number listed in your letter. We are glad to offer assistance and work with you, so we welcome your call or email. Voluntary compliance is always the Town's goal.

ELEMENTARY SCHOOL PARKING & SCHOOL ZONE UPDATES

There has been an increase in vehicles parking on the east side of Main Street across from the elementary school to drop off students. This practice has created traffic conflicts and safety issues, including prohibited jaywalking. Parents are reminded to make full use of the drop-off lane in front of the school. If you want to walk your child to the school, please park in the lot north of the preschool. Starting in 2022 parking on the east side of Main Street will be restricted to those residents who actually live or work on Main Street.



Please obey the school speed limit signs and no U-Turn signs in the school zone. Police have increased their enforcement of both laws, and several people have already received tickets for violations. The school zone is active from 7:30am-8:00am and 3:15pm-3:45pm.

PROOF OF INSURANCE REQUIRED!!

Officers of the Wiggins Police Department have noticed an increase in motorists driving without proof of insurance readily available within their vehicle. State law requires <u>ALL</u> Colorado residents to maintain proof of current insur-

ance with you in the form of a printed-off copy (most convenient) or on a phone app that can be READILY accessed. Be sure you have an immediate link or a screenshot. For the officer's safety, they will not stand-by on the side of the road for more than a few minutes waiting for this information. Police Officers prefer to give traffic warnings, but if you cannot show proof of insurance then you will be a guaranteed ticket. Lack of proof insurance may result in immediate suspension of your drivers license and impoundment of your vehicle. Thank you!

Citation - Ticket Payments

You can pay your citation online! If your citation is not a summons to court and the citation is for the Town of Wiggins Municipal Court, then you may pay on our new website.

- Go to <u>townofwiggins.colorado.gov</u> . Click "Pay Online"
- Your ticket/citation number is in the top right corner.
- Be sure it states Wiggins Municipal Court at the bottom & not Morgan County!!



LEAP PROGRAM

The Colorado Low-income Energy Assistance Program (LEAP) is a federally funded program that helps eligible hardworking Colorado families, seniors and individuals pay a portion of their winter home heating costs. Our goal is to help bring warmth, comfort and safety to your home and family by assisting with heating costs.

The LEAP program works to keep communities warm during the winter (November through April) by providing assistance with heating costs, equipment repair and/or replacement of inoperable heating tools. While the program is not intended to pay the entire cost of home heating, we aim to help alleviate some of the burdens that come with Colorado's colder months. In most cases, the energy assistance benefit is paid directly to the household energy supplier.

In most cases, if you are approved for LEAP, payments are made directly to your primary heating fuel vendor and a notice will be sent to you informing you of the benefit amount. Other benefits provided by LEAP include repair or replacement of a home's primary heating system, such as a furnace or woodburning stove. The program does not provide financial assistance for any type of temporary or portable heating.

Snow Removal



As winter conditions are occurring, please remember to limit parking on the street to assist snow plow drivers with snow removal operations. This will prevent your vehicle

from being blocked by snow berms.

The Public Works Department strives to remove snow from streets as quickly as possible. However, primary streets are given priority attention and then the residential streets are cleared.

<u>HOMEOWNERS</u> - Per the Health & Safety Ordinance, homeowners are required to remove snow located on residential sidewalks within 24 hours after snowfall has stopped.

Planning & Zoning Commission Vacancies

The Board of Trustees recently passed a resolution to create a citizen led Planning & Zoning Commission to make Land Use Application recommendations to the Board of Trustees. The Town invites interested residents to apply for these positions. Applications may be found on the Town's home webpage.

The Planning & Zoning Commission meets once a month on the second Tuesday of each month when there is an application to be reviewed. The Planning & Zoning Commissioner's primary responsibility is to make land use decisions that are consistent with the Town policies and plans formally adopted by the Board of Trustees. All comments and recommendations are then passed on to the Board of Trustees for a final decision.

 - * Account number & name will be required to create an account <u>OR</u> for making one time payments online.
 - * DO NOT USE A DECIMAL POINT WHEN ENTERING ACCOUNT NUMBER.
